A Resolution appointing Darryl Restagno to serve on the Board of Plumbing.

WHEREAS, pursuant to the Codified Ordinances of the City of Harrisburg § 8-105.7, the City of Harrisburg shall appoint five (5) members to the Board of Plumbing (the "Board"); and

WHEREAS, pursuant to § 8-105.7A., the members of the Board shall consist of one (1) professional engineer; one (1) master plumber; one (1) journeyman plumber; one (1) lay member; and, one (1) employee of the City serving in the Department of Building and Housing Development; and

WHEREAS, appointments to the Board shall be made by the Mayor, and shall be confirmed or rejected by Council within thirty (30) days of the date of the appointment, or the appointment shall be deemed approved; and

WHEREAS, pursuant to § 8-105.7A, each member of the Board shall serve for a term of three (3) years commencing from the date of appointment, except that two (2) persons initially appointed to the Board shall be chosen for a term of three (3) years, two (2) for a term of two (2) years, and one (1) for a term of one (1) year; and

WHEREAS, the Mayor has appointed Darryl Restagno to serve on the Board as the representative City employee; and

WHEREAS, reposing confidence and trust in the ability of Mr. Restagno to capably perform the duties incumbent upon the position, the Mayor has appointed Mr. Restagno to serve on the Board; and

WHEREAS, Mr. Restagno shall be appointed to the Board for a period of one (1) year; and

WHEREAS, Mr. Restagno's qualifications to serve as a member of the Plumbing Board have been reviewed and considered by Council. A copy of Mr. Restagno's resume is attached as Exhibit "A".

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED BY THE COUNCIL OF THE CITY OF HARRISBURG, that the appointment of Darryl Restagno to serve on the Plumbing Board for a period of one (1) year is confirmed.
