A Resolution authorizing the execution of a federal aid reimbursement agreement with the Pennsylvania Department of Transportation for acceptance of Transportation Alternatives Program Funding for the Riverwalk Project.

WHEREAS, the City applied for the Pennsylvania Department of Transportation (PennDOT) Transportation Alternatives Program (TAP) Funding for the Riverwalk Project; and

WHEREAS, the purpose of the project is to improve pedestrian and bicycle accommodations as well as access to the Susquehanna River via the Riverwalk in Riverfront Park (Riverwalk Project); and

WHEREAS, by way of Resolution 8-2016, Council ratified the submission of a grant application to PennDOT for the Riverwalk Project; and

WHEREAS, the City of Harrisburg was awarded \$1,500,000 in TAP Funding for improvements to the Riverwalk, a multi-use path along the Susquehanna River; and

WHEREAS, the PennDOT TAP Funding award requires a municipal designee to electronically execute the PennDOT TAP Funding Reimbursement Agreement in order to effectuate the award.

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED BY THE COUNCIL OF THE CITY OF HARRISBURG, that acceptance of the PennDOT TAP Funding is approved.

BE IT FURTHER RESOLVED that the Mayor and City Controller are authorized to execute a designation, hereto attached as 'Exhibit A,' that the City Engineer, Wayne S. Martin, is authorized to sign and execute on behalf of the City of Harrisburg, any and all materials required for execution via PennDOT's Reimbursement Agreement System (RAS) for the

requested federal aid reimbursement agreement #R18080003 and any required supplements between the City of Harrisburg and the Pennsylvania Department of Transportation and have the same delivered to the Commonwealth of Pennsylvania.
