A Resolution to recognize the 300 block of Emerald Street as Jacqueline Black Way.

WHEREAS, Jacqueline J. Black was born on June 12, 1951 in the City of Harrisburg; and

WHEREAS, Ms. Black was a product of the Harrisburg Public School System, having attended the former William Penn High School; and

WHEREAS, Ms. Black was a dedicated and hard worker, having retired from Hershey Foods, and later being employed at Turning Points Early Education Center; and

WHEREAS, in her lifetime, Ms. Black was a devoted and loving daughter, sister, aunt, friend, wife, mother, grandmother and great-grandmother; and

WHEREAS, Ms. Black was a beloved member of the Harrisburg community who lived on the 300 block of Emerald Street in the City of Harrisburg for approximately 40 years; and

WHEREAS, Ms. Black's devotion to her family was clearly shown on June 16, 2018, when Ms. Black helped three of her grandchildren escape a house fire by having them jump out of the second story windows of her Emerald Street home; and

WHEREAS, tragically, Ms. Black died on June 16, 2018, as she was not able to escape the house fire; and

WHEREAS, Jacqueline Black's heroism, devotion to family and love for the Harrisburg community shall serve as a lasting legacy of a life well-lived.

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED BY THE COUNCIL OF THE CITY OF HARRISBURG that the 300 block of Emerald Street in the City of Harrisburg is recognized as "Jacqueline Black Way."


