A Resolution to correct Resolution 2-2019, confirming the reappointment of Ms. Gretchen M. Little to serve on the Harrisburg Human Relations Commission ("HHRC"), by changing the term of service from one year to three years.

**WHEREAS**, On February 19, 2019, City Council passed Resolution 2-2019, confirming the reappointment of Ms. Gretchen Little to serve on the HHRC for a one-year term expiring November 14, 2019; and

**WHEREAS**, pursuant to the § 4-103.3 of the Codified Ordinances of the City of Harrisburg, "[p]ersons appointed and qualified as Commissioners [of the HHRC] shall serve for a term of three years;" and

**WHEREAS**, Resolution 2-2019 must be corrected to conform with the term of service requirements of § 4-103.3;" and

**WHEREAS**, under a three-year term, Ms. Little's reappointment will expire on November 14, 2021.

**NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED BY THE COUNCIL OF THE CITY OF HARRISBURG** that Resolution 2-2019 is corrected to reflect that Ms. Gretchen M. Little's reappointment shall be for a three-year term expiring on November 14, 2021.
