A Resolution to correct Resolution 3-2019, confirming the appointment of Mr. Kevin E. Burrell to serve on the Harrisburg Human Relations Commission ("HHRC"), by changing the term of service from one year to three years.

WHEREAS, On February 19, 2019, City Council passed Resolution 3-2019, confirming the appointment of Mr. Kevin Burrell to serve on the HHRC for a one-year term expiring November 14, 2019; and

WHEREAS, pursuant to the § 4-103.3 of the Codified Ordinances of the City of Harrisburg, "[p]ersons appointed and qualified as Commissioners [of the HHRC] shall serve for a term of three years;" and

WHEREAS, Resolution 2-2019 must be corrected to conform with the term of service requirements of § 4-103.3;" and

WHEREAS, under a three-year term, Mr. Burrell's appointment will expire on November 14, 2021.

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED BY THE COUNCIL OF THE CITY OF HARRISBURG that Resolution 3-2019 is corrected to reflect that Mr. Kevin E. Burrell's appointment shall be for a three-year term expiring on November 14, 2021.
