

RESOLUTION NO. 76 - 2018

A Resolution appointing Clem Onukwubiri to serve on the Building and Housing Code Board of Appeals of the City of Harrisburg.

WHEREAS, pursuant to the Codified Ordinances of the City of Harrisburg § 8-501.1, the Building and Housing Code Board of Appeals (the "Board") shall be comprised of five (5) members who are appointed by the Mayor with the advice and consent of Council; and

WHEREAS, appointees to the Board shall be residents of the City of Harrisburg and shall each serve for a term of three (3) years; and

WHEREAS, due to a vacancy in the seat formerly occupied by Mr. H. Edward Wenger, the Mayor has appointed Clem Onukwubiri to serve on the Board; and

WHEREAS, appointees to the Board shall hold no other office or employment in the government of the City or serve on any of its boards, commissions, or authorities; and

WHEREAS, Mr. Clem Onukwubiri is a resident of the City of Harrisburg; and

WHEREAS, Mr. Onukwubiri holds no other office or employment in the government of the City and does not serve on any of its boards, commissions, or authorities; and

WHEREAS, Mr. Onukwubiri's qualifications to serve on the Board have been carefully reviewed and considered by City Council. A redacted copy of Mr. Onukwubiri's resume is attached and incorporated as "Exhibit A;" and

WHEREAS, Mr. Onukwubiri is currently the owner of Donchek Electrical Services; and


WHEREAS, Mr. Onukwubiri has over 10 years' experience in the electrical field, including 3 years' experience as a Master Electrician; and

WHEREAS, pursuant to § 8-501.1.C. of the Codified Ordinances of the City of Harrisburg, appointments to fill vacancies to the Board shall only be for the unexpired portion of the term; and

WHEREAS, Mr. Onukwubiri's appointment to the Board shall be for the remainder of Mr. Wenger's term, expiring on September 28, 2019.

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED BY THE COUNCIL OF THE CITY OF HARRISBURG, that Clem Onukwubiri's appointment to the Building and Housing Code Board of Appeals of the City of Harrisburg is hereby confirmed.


