

RESOLUTION NO. 71 - 2019

A Resolution confirming the appointment of Mr. Brian Enterline to serve as a member of the Board of Directors of the Susquehanna Area Regional Airport Authority (SARAA).

**WHEREAS**, the Mayor of the City of Harrisburg appoints two (2) members of the Board of the Susquehanna Area Regional Airport Authority ("SARAA"), a joint authority whose obligations include certain responsibilities relating to the operations of the Harrisburg International Airport; and

**WHEREAS**, members of the SARAA Board of Directors are volunteers appointed by the elected officials from the counties of Cumberland, Dauphin and York, the cities of Harrisburg and York, and the townships of Fairview and Lower Swatara; and

**WHEREAS**, in accordance with the Municipal Authorities Act, 53 Pa.C.S.A. § 5601, et seq., and the Bylaws of SARAA, members of the Board are appointed for a term of five years, and thereafter, in the event of a vacancy, a successor shall be appointed for a term of five years or the remainder of a yet unexpired term of the appointee's predecessor, whichever shall be applicable; and

**WHEREAS**, the Mayor is the appointing authority for vacancies arising under the Municipal Authorities Act, with the advice and consent of the City Council by Resolution; and

**WHEREAS**, due to the departure of Ronald K. Rouse, there exists one (1) vacancy on the SARAA Board of Directors to be filled by the City of Harrisburg; and

**WHEREAS**, reposing trust and confidence in her abilities to represent the interests of the City of Harrisburg on the SARAA Board of Directors and to perform the duties required of a member thereof, the Mayor of the City Harrisburg has appointed Mr. Brian Enterline to serve on the SARAA Board of Directors; and

**WHEREAS**, as the Fire Chief for the Fire Bureau for the City of Harrisburg, and in consideration of his rich professional and educational experiences, as reflected more fully in his resume, attached hereto and marked as "Exhibit A," Mr. Enterline is well qualified to serve as the City's appointee to the SARAA Board of Directors; and

**WHEREAS**, Mr. Enterline's qualifications to serve on the SARAA Board of Directors have been reviewed and considered by City Council.

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED BY THE COUNCIL OF THE CITY OF HARRISBURG that the appointment of Brian Enterline to serve as a City representative on the Board of Directors of the Susquehanna Area Regional Airport Authority (SARAA) is confirmed, for a term expiring January 5, 2022.
