Application Reviews

Application No. PB-305 Jayne's Riverview – Parcel J Subdivision - For review of preliminary subdivision approval of a 107 single family lot residential subdivision located on Farrell Road Extension in a R-1-15 Residential Zoned District. Tax Account No. 187.02-2-1.11.

Representing Applicant: Martin Janda, BME Associates

A. The Applicant stated the following:

1. The Town Engineer reviewed the Town Law §278 calculation on May 23, 2016 and agreed with the one hundred and seven (107) lot configuration.
2. Trees were added since the previous plans; one hundred sixty-seven (167) trees and ninety-four (94) bushes are required, and more than that have been provided. Six to eight (6-8) various tree types will be used. Entrance landscaping, berm screening, pond landscaping and trees within the cul-de-sac were added.

B. The Henrietta Conservation Board recommends to the Planning Board:

1. The use of salt tolerant trees is recommended, as well as the creation of a snow storage space at the cul-de-sac's.

On a motion by Robbin Ciavaglia, seconded by Christian Chamberlain, Application No. PB-305 was recommended to the Henrietta Planning Board to be approved.

Application No. 16-008 Empire Fabricators Building Addition – For review of final site plan approval of a 28,125 S.F. building addition located at 95 Saginaw Drive in an Industrial Zoned District. Tax Account No. 162.11-1-10 and 162.11-1-11.2.

Representing Applicant: None

A. The Applicant stated the following:

1. The applicant was not present.

B. The Henrietta Conservation Board recommends to the Planning Board:

1. The applicant needs to provide proof of replacement of the existing significant trees in addition to adding eight (8) trees per disturbed acre.
2. The Board would like to see the stormwater system described. It appears that the stormwater is flowing unabated off the property.
3. Review the five hundred and three foot (503') grade at the building interface which appears to have the potential to collect stormwater.
4. Lighting appears to be dark sky compliant, which is good.
