 - 1. There is a safety concern due to the lack of pedestrian and bicycle trails and pathways to access outside amenities. The concern applies to both on site and off site.
 - 2. Confirm the green space in the 73 acre area that is part of this application. What is the intent of the other lots that are not a part of this application? Are the remaining acres going to remain as green space?
 - 3. Does the application meet the standard eight (8) trees per acre? Confirm that the access roadway acreage is included in the proposal.
 - 4. Describe the storm water flow, confirm management practices, and what parts of the site they will control.
 - 5. Is the lighting dark sky compliant in order to decrease light pollution, or is it similar to the existing lighting at nearby campus housing that has caused a dramatic amount of light pollution?
 - 6. Will the roadway and ponds be maintained by the Owner?
 - 7. Application will be tabled due to the Applicant requesting late this afternoon that they be removed from tonight's agenda.
