- Gary had asked if the cut and fill grading changed since review on Canandaigua National Bank at Castle Road. (Concerned about safety and soil certifications)
- Bud Snyder asked if Gates Automotive addition should have come before the Henrietta Conservation Board. Mr. Santos stated usually does not happen if the green space is still within the standards, and use is the same.

Representing Applicant: Craig Eckert, Passero Associates

- A. The Applicant stated the following:
 - 1.) The south and east sides will be low maintenance shrubs with either stone or bark or mulch.
 - 2.) The neighbors selected a vinyl fence type and look for the entire property line.
 - 3.) The street intersection will be aligned with Cracker Barrel.
 - 4.) The storm water filtration system will be ahead of the underground storm water storage facility.
 - 5.) The snow storage is limited, and will have to be transported, if excessive.
 - 6.) The green space is based upon combining parcels.
 - 7.) The consultant comments from the August 5, 2008 were discussed. Increased landscaping will be provided along the fence, as well as revising some types to mix varieties.
 - 8.) The light pole heights and quantities were lowered to decrease light pollution.
 - 9.) The target audience of renters will be couples and/or professionals with two (2) year leases.
 - 10.) Storm water system will handle new run-off.
 - Summer Sky forced main sanitary will be eliminated and tied into the new system.
 - 12.) A letter dated August 27, 2008, from Precision Properties has been submitted for the Minutes.
- B. The Henrietta Conservation Board recommends to the Planning Board:
 - 1.) Updated and complete landscaping plans were not available at the time of meeting, please have the Applicant submit final plan when complete.
