In regards to the above referenced application, the applicant presented revised colored building elevations to the Planning Board for review. Several Planning Board members still had some concerns regarding the

western building elevation as they would like to see less brick and more of a “whites” façade instead. The Board also noted that they would like to see the yellow arch brought to the front of the building. After much discussion, the western building elevation must be revised per a marked up drawing provided by the Planning Board. This revised building elevation must be reviewed administratively and approved by the Planning Board Chairman and the Director of Engineering & Planning.


In regards to the above referenced application, the applicant presented a revised site plan for the Delta Sonic redevelopment. The application was previously approved on January 10, 2017 and the applicant noted that there had been numerous revisions to the drawings. The Henrietta Planning Board reviewed and approved the proposed revisions.

DISCUSSION ITEM: **Racquet Club Student Housing** – For final site plan approval of a new student housing apartment building on 12.4 acres located at 4000 East River Road in a Residential R-2-15 Zoned District. Tax Account No. 174.01-2-58.1.

In regards to the above referenced application, the applicant presented a new student housing apartment building project. The project consists of providing an eighty-one unit building on twelve point four acres of land that is located directly adjacent to two existing four story apartment units. A shuttle bus service will be provided from the apartments to the campus of R.I.T. A traffic impact study was provided for the project and is currently being reviewed by both the Monroe County Department of Transportation and by the Town of Henrietta’s traffic consultant. There will be a concrete sidewalk provided along Fairwood Drive as well. The Henrietta Planning Board noted its support of the project. [*Town Clerk’s Note: This application will be heard by the Henrietta Town Board for Special Use Permit approval on April 25, 2018 and then will return for final site plan approval by the Henrietta Planning Board on May 1, 2018.*]
