ORDINANCE TO EXCEED THE 2017 MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A:4-45.14)

WHEREAS, the Local Government Cap Law, <u>N.J.S.A.</u> 40A:4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 2.0% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and

WHEREAS, N.J.S.A. 40A:4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriations and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and

WHEREAS, the Township Committee finds it advisable and necessary to increase its CY 2017 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and

WHEREAS, the Township Committee hereby determines that a 3.5% increase in the budget for said year, amounting to \$893,327.65 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and

WHEREAS, the Township Committee hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as a cap exception to final appropriation in either of the next two succeeding years;

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Hillsborough, County of Somerset, State of New Jersey, a majority of the full authorized membership of the Township Committee affirmatively concurring, that in the CY 2017 budget year, the final appropriations of the Township of Hillsborough shall, in accordance with this ordinance and N.J.S.A. 40A:4-45.14, be increased by 3.5%, amounting to \$893,327.65 and that the CY 2017 municipal budget for the Township of Hillsborough be approved and adopted in accordance with this ordinance; and

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

Mayor Suraci stated as indicated when this ordinance was introduced, under state budget law the unused portion of the appropriations cap, which is different than the tax levy cap, may be reserved to be available

in the next two years. Each year since 2002 Hillsborough has been able to reserve some funds in the cap bank. The cap bank has no impact on taxes.

Upon motion by Deputy Mayor McCauley, seconded by Committeeman Tomson, to open the public hearing, the resolution was unanimously approved upon call of the role.

Upon motion by Committeeman Tomson, seconded by Deputy Mayor McCauley, the public hearing was closed and Ordinance 2017-04 was adopted and unanimously approved upon call of the role.

WHEREAS, pursuant to N.J.S.A. 40A:4-8, the municipal budget as advertised may be read by its title at the public hearing provided a complete copy of the approved budget, as advertised, is made available for public inspection in the free public library, if any, of the municipality and in the free county libraries or regional libraries located in the municipality and is made available to each person requesting the same at least one week prior to the date of the public hearing and during the public hearing; and

WHEREAS, the Township Committee of the Township of Hillsborough hereby determines that the above conditions have been met.

NOW, THEREFORE, BE IT RESOLVED that the 2017 municipal budget shall be read by title only.

Upon motion by Deputy Mayor McCauley, seconded by Committeeman Tomson, the aforesaid resolution was unanimously approved upon call of the role.

2. RESOLUTION ADOPTING THE 2017 MUNICIPAL BUDGET

WHEREAS, the 2017 Municipal Budget was introduced and approved by the Hillsborough Township Committee on April 25, 2017 at a regularly scheduled Township Committee meeting; and

WHEREAS, the Public Hearing for the 2017 Municipal Budget was held on May 23, 2017, at a regularly scheduled Township Committee meeting, at which said budget was read by title only.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Hillsborough, County of Somerset, State of New Jersey, that the 2017 Hillsborough Municipal Budget totaling \$28,954,044.00 is hereby adopted and that two certified copies of the same be forwarded to the Director of the Division of Local Government Services and a certified copy of the same be forwarded to the Somerset County Board of Taxation.

Deputy Mayor McCauley stated this is the 7th consecutive year that the budget has come in below the 2% tax levy cap, receiving no additional state aid.

Mayor Suraci stated he echoed Deputy Mayor McCauley's sentiments and reiterated the financially responsible budget has come below the 2% cap. This has been the practice in Hillsborough and saves the taxpayers \$194,000. Mayor Suraci explained for residents whose property has not appreciated in value there will be no increase in the municipal portion of the tax bill.

Jane Staats, Devonshire Court stated she was concerned about the sustainability of the budget as well as some services.

Committeeman Tomson responded to Ms. Staats concerns.

Mayor Suraci stated Hillsborough gets no state aid and the Township has to prioritize.

Harry Burke stated his concerns regarding the budget and reduced services.

Deputy Mayor McCauley stated she that no services have been cut that residents expect.

Mayor Suraci stated in conclusion Hillsborough is lowest spent per capita which is a measure of efficiency for a municipality.

Upon motion by Deputy Mayor McCauley, seconded by Committeeman Tomson, the aforesaid resolution was unanimously approved upon call of the role.
