




Incident Blotter

04/07/2019	Nasson Harrington, 31, Trenton NJ, was arrested for DWI after being stopped in his vehicle on Rt. 206. He was issued additional summonses for having a suspended driver license, failing to exhibit a registration and failing to maintain vehicle lamps. He was processed and released pending a court appearance.
04/07/2019	Stephanie McGibbon, 41, Hillsborough NJ, was arrested for DWI after being stopped in her vehicle on Beekman Lane. She was issued an additional summons for failing to inspect. She was processed and released pending a court appearance.
