


Incident Blotter

<u>Date</u>	<u>Incident Description and/or Those Involved</u>
6/3/2019	Prakasar Mandadi, 66, of Flemington was arrested for driving under the influence after his vehicle was stopped by police on Amwell Road. His blood alcohol content was found to be 0.17%. Mandadi was also charged with careless driving, delaying traffic, failure to produce documents, failure to maintain lane and improper turn signal. He was processed and released pending a court appearance.
6/8/2019	Andrae Pearson, 28, of Linden and Naomi Santos, 24, of Hillsborough were arrested for possession of Marijuana and possession of drug paraphernalia when it was found in their possession after their vehicle was stopped by police on Amwell Road. Pearson was also charged with speeding. Both were processed and released pending a court appearance.
