ORDINANCE 2019-15

An Ordinance Appropriating Certain Monies Held by the Township of Hillsborough, County of Somerset, State of New Jersey, for the Purchase of Various Capital Improvements in the Amount of \$676,578.00 in and for the Township of Hillsborough. Further Consideration Of This Ordinance And Public Hearing Will Be Held On September 10, 2019.

WHEREAS, there are funds available in the Hillsborough Township Capital Improvement Fund in the amount of \$488,943.00 and

WHEREAS, the following off-site contributions have been received from various developers to be utilized for walking path improvements, erosion control and sidewalk replacements throughout the Township, and

WHEREAS, the Township has received a Clean Communities Grant and will appropriate \$10,000.00 of those funds; and

WHEREAS, the Hillsborough Rotary Club will donate \$21,000.00 towards the purchase of a Wheelchair Accessible Bus; and

WHEREAS, the Hillsborough Township Committee has determined there is a need to appropriate the aforesaid Capital funds for the following purposes and amounts:

3.	Handicapped Parking at AVM Basketball Court	15,650.00
4.	Walking Path Rehab Woodfield Park to Case Blvd.	19,135.00

6.	¾ Ton 4-WD Pick-up with Snow Plow	42,000.00
7.	Street Sweeper	220,000.00
8.	Municipal Building Upgrades	15,000.00
9.	Erosion Control Mountainview Road	100,000.00

NOW THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Hillsborough, County of Somerset, State of New Jersey, that the aforementioned sums are hereby appropriated.

BE IT FURTHER ORDAINED, that the capital budget is hereby amended to conform with the provisions of this ordinance to the

extent of an inconsistency therewith and the resolutions promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services is on file with the municipal clerk and is available for public inspection.

This ordinance shall take effect upon final adoption and publication according to law.
