

**Explanation:** This Ordinance amends Section 117-11 of the Code of the Township of Hillsborough, titled “License and registration tag fees”, by changing the annual dog license fee in Section 117-11A to \$14.80 for the period between January 1, 2011 to December 31, 2011, and \$19.80 thereafter.

**ORDINANCE 2010-37**

**AN ORDINANCE AMENDING SECTION 117-11 OF THE CODE OF THE TOWNSHIP OF HILLSBOROUGH, TITLED “LICENSE AND REGISTRATION TAG FEES”, BY CHANGING THE ANNUAL DOG LICENSE FEE IN SECTION 117-11A TO \$14.80 FOR THE PERIOD BETWEEN JANUARY 1, 2011 TO DECEMBER 31, 2011, AND \$19.80 THEREAFTER.**

**BE IT ORDAINED**, by the Township Committee of the Township of Hillsborough in the County of Somerset and State of New Jersey, as follows:

**Section 1.** Section 117-11 of the Code of the Township of Hillsborough, titled “License and registration tag fees”, is hereby amended as follows:<sup>1</sup>

**§117-11 License and registration tag fees.**

- A. A person who shall own, keep or harbor a dog required to be licensed under the provisions of N.J.S.A. 4:19-1 et seq. shall make application to the Township Clerk for a license and registration tag for such dog within the time limited by the aforesaid statute and shall pay an annual license fee per dog of \$7 until December 31, 2010, and \$14.80 from January 1, 2011 through December 31, 2011, and \$19.80 thereafter, and \$1 for each registration tag and renewal thereof.
- B. In addition, in order to comply with P.L. 1983, c. 181, the Clerk will be required to collect and remit to the state, together with the dog registration tag fee of \$1, \$0.20 for each dog licensed, to be designated for the State Pilot Clinic Fund.
- C. Further, in compliance with P.L. 1983, c. 172, the Clerk will be required to collect and remit to the State Department of Health, together with the dog

registration fee and the \$0.20 cited above, an additional \$3 for any dog of reproductive age which has not had its reproductive capacity permanently altered through sterilization. This fee is to be designated for the Animal Population Control Fund.

**Section 2. Severability.**

If any section, paragraph, subdivision, clause or provision of this Section shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision and the remainder of this Section shall be deemed valid and effective.

**Section 3. Effective Date.**

This Ordinance shall take effect as provided by law.
