

**ORDINANCE 2009-20**

**AN ORDINANCE APPROPRIATING CERTAIN MONIES HELD BY AND CONTRIBUTIONS TO BE RECEIVED BY THE TOWNSHIP OF HILLSBOROUGH, COUNTY OF SOMERSET, STATE OF NEW JERSEY, FOR THE PURCHASE OF VARIOUS CAPITAL IMPROVEMENTS IN THE AMOUNT OF \$938,000.00, IN AND FOR THE TOWNSHIP OF HILLSBOROUGH.**

**WHEREAS**, there are funds available in the Hillsborough Township Capital Improvement Fund in the amount of \$353,000.00; and

**WHEREAS**, the following off-site contributions of \$260,000.00 have been received from various developers to be utilized for general improvements throughout the Township in accordance with Planning Board resolutions of approval; and
