**TOWNSHIP OF HILLSBOROUGH
ORDINANCE NO. 2008-19**

**AN ORDINANCE AMENDING CHAPTER 169 OF THE CODE OF THE TOWNSHIP OF
HILLSBOROUGH, TITLED “FIRE ZONES”, SECTION 5, TITLED “FIRE ZONES
DESIGNATED.”**

BE IT ORDAINED by the Township Committee of the Township of Hillsborough, County of Somerset, State of New Jersey, that Chapter 169 of the Code of the Township of Hillsborough, titled “Fire Zones”, Chapter 5, titled “Fire Zones Designated”, is hereby amended as follows:

Section 1. Section 169-5 is hereby amended by adding the following:

(70) The Glen-Bloomingdale Drive and Taurus Drive (Block 163.07)

(a) Beginning at the southeast corner of building 21 Bloomingdale Drive and extending 87 feet south, then extending 293 feet north to Bloomingdale Drive for the entire width of the driveway, to include the circular stone area in the center of the building cluster.

(b) Beginning at the southeast corner of building 23 Bloomingdale Drive and extending 63 feet southwest for the entire width of the driveway, to include the circular stone area in the center of the building cluster.

(c) Beginning at the northeast corner of building 24 Bloomingdale Drive and extending 81 feet northeast for the entire width of the driveway, to include the circular stone area in the center of the building cluster.

(d) Beginning at the northwest corner of building 25 Bloomingdale Drive and extending 70 feet northeast for the entire width of the driveway, to include the circular stone area in the center of the building cluster.

(e) Beginning at the northeast corner of building 26 Bloomingdale Drive and extending 91 feet southeast for the entire width of the driveway, to include the circular stone area in the center of the building cluster.

(f) Beginning at the northeast corner of building 27 Bloomingdale Drive extending 78 feet southwest for the entire width of the driveway, to include the circular stone area in

the center of the building cluster

(g) Beginning at the northeast corner of building 29 Bloomingdale Drive extending 77 feet east, then extending 103 feet north to Bloomingdale Drive for the entire width of the driveway, to include the circular stone area in the center of the building cluster

(h) Beginning at the southeast corner of building 51 Taurus Drive extending 68 feet east for the entire width of the driveway, to include the circular stone area in the center of the building cluster.

(i) Beginning at the southeast corner of building 53 Taurus Drive extending 64 feet west for the entire width of the driveway, to include the circular stone area in the center of the building cluster

(j) Beginning at the northeast corner of building 55 Taurus Drive extending 306 feet northeast to Taurus Drive for the entire width of the driveway, to include the circular stone area in the center of the building cluster

(k) Beginning at the northeast corner of building 57 Taurus Drive extending 66 feet southeast for the entire width of the driveway, to include the circular stone area in the center of the building cluster

(l) Beginning at the southeast corner of building 59 Taurus Drive extending 78 feet west for the entire width of the driveway, to include the circular stone area in the center of the building cluster

(m) Beginning at the southwest corner of building 61 Taurus Drive extending 74 feet southeast, then extending 115 feet northeast to Taurus Drive for the entire width of the driveway, to include the circular stone area in the center of the building cluster.

Section 2. Effective Date.

This Ordinance shall take effect as provided by law.
