**AN ORDINANCE AMENDING SECTION 143-37,  
SCHEULE VIII OF THE CODE OF THE TOWNSHIP OF  
HILLSBOROUGH, TITLED “THROUGH STREETS.”**

**BE IT ORDAINED** by the Township Committee of the Township of Hillsborough, County of Somerset, State of New Jersey, that Section 143-37, Schedule VIII of the Code of the Township of Hillsborough, titled “Through Streets” is amended by adding the following through streets:

Section 1. Additional Through Streets.

Carroll Drive	Between River Road and its easterly terminus

Collins Drive	Between Amsterdam Drive and Milburn Drive
Crestmont Drive	Between Triangle Road and Auten Road
Fairfield Lane	Between Valinor Road and its easterly terminus

Garretson Lane	Between Roycebrook Road and its easterly terminus
Holecomb Drive	Between Amsterdam Drive and its easterly terminus
Independence Drive	Entire Length
Lindstrom Drive	Between Route US 206 and its northerly terminus
Matrick Court	Between Holecomb Drive and its easterly terminus
Matthew Road	Between Willow Road and Scott Drive
Milburn Drive	Between Amsterdam Drive and its easterly terminus
Onka Drive	Between Millstone River Road and its easterly terminus
Orchard Drive-Crater Road Drive	Between New Centre Road and Carroll Drive
Oxford Place	Entire Length
Perrine Pike	Between Triangle Road (easterly intersection) and Triangle Road (westerly intersection)
Pierson Drive	Entire Length
Pioneer Drive	Between Amwell Road and its northerly terminus
Stagecoach Way	Between South Woods Road and its easterly terminus
Stockton Road	Between Triangle Road and Hughey Lane
Stout Drive	Between Milburn Drive and its southerly terminus
