AN ORDINANCE AMENDING ORDINANCE 2006-13 ENTITLED “APPROPRIATING CERTAIN MONIES HELD BY AND CONTRIBUTIONS TO BE RECEIVED BY THE TOWNSHIP OF HILLSBOROUGH, COUNTY OF SOMERSET, STATE OF NEW JERSEY, FOR THE PURCHASE OF VARIOUS CAPITAL IMPROVEMENTS IN THE AMOUNT OF \$1,698,950, IN AND FOR THE TOWNSHIP OF HILLSBOROUGH. “
