**TOWNSHIP OF HILLSBOROUGH
ORDINANCE NO. 2006-50**

**AN ORDINANCE AMENDING CHAPTER 169 OF THE CODE OF THE TOWNSHIP OF
HILLSBOROUGH, TITLED “FIRE ZONES”, SECTION 5, TITLED “FIRE ZONES
DESIGNATED.”**

BE IT ORDAINED by the Township Committee of the Township of Hillsborough, County of Somerset, State of New Jersey, that Chapter 169 of the Code of the Township of Hillsborough, titled “Fire Zones”, Chapter 5, titled “Fire Zones Designated”, is hereby amended as follows:

Section 1. Section 169-5(17) is hereby deleted without renumbering the subsequent paragraphs and is intentionally omitted.

Section 2. Section 169-5 is hereby amended by adding the following:

- (64) 331 Route 206 (Block 182, Lot 38)
 - (a) Beginning at the southeast corner of the building extending 195 feet south.
- (65) 393 Amwell Road (Block 199, Lot 49)
 - (a) Beginning at the eastern driveway entrance extending 590 feet northeast.
 - (b) Beginning at the northwest corner of the building extending 515 feet south.
- (66) 335 Amwell Road (Block 32, Lot 199)
 - (a) Beginning at the southeast corner of the building extending 432 feet northeast.
 - (b) Beginning at the southeast corner of the building extending 418 feet northeast.
- (67) Wildflower Village Wildflower Lane (Block 153.15)
 - (a) Beginning at 226 Wildflower Lane extending 179 feet south.
 - (b) Beginning at 260 Wildflower Lane extending 120 feet south.

(c) Beginning at 160 Wildflower Lane extending 159 feet northwest.

(d) Beginning at 150 Wildflower Lane extending 109 feet north.

Section 3. Severability.

If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision and the remainder of this Ordinance shall be deemed valid and effective.

Section 4. Effective Date.

This Ordinance shall take effect as provided by law.
