

ORDINANCE 2004-15

AN ORDINANCE AMENDING ORDINANCE 2003-18 ENTITLED “APPROPRIATING CERTAIN MONIES HELD BY AND A GRANT OBTAINED BY THE TOWNSHIP OF HILLSBOROUGH, COUNTY OF SOMERSET, STATE OF NEW JERSEY, FOR THE PURCHASE OF VARIOUS CAPITAL IMPROVEMENTS IN THE AMOUNT OF \$1,265,495, IN AND FOR THE TOWNSHIP OF HILLSBOROUGH.”

BE IT ORDAINED by the Township Committee of the Township of Hillsborough, in the County of Somerset, State of New Jersey, that Ordinance 2003-18 is hereby amended as follows:

WHEREAS, there exists in the Hillsborough Township Capital Improvement Fund a sum of ~~\$568,400.00~~ 567,400; and

WHEREAS, ~~a grant/grants~~ has/have been awarded by the State of New Jersey, Department of Transportation, Transportation Trust Fund Local Pedestrian Program for \$100,000.00 and New Jersey Department of Transportation, Transportation Trust Fund for \$80,000.; and

WHEREAS, the following off-site contributions have been received from various developers to be utilized for general improvements throughout the Township in accordance with Planning Board resolutions of approval; and
