

**ORDINANCE 2004-17**

**AN ORDINANCE APPROPRIATING CERTAIN MONIES HELD BY AND CONTRIBUTIONS TO BE RECEIVED BY THE TOWNSHIP OF HILLSBOROUGH, COUNTY OF SOMERSET, STATE OF NEW JERSEY, FOR THE PURPOSE OF VARIOUS CAPITAL IMPROVEMENTS IN THE AMOUNT OF \$1,307,500, IN AND FOR THE TOWNSHIP OF HILLSBOROUGH.**

**WHEREAS**, there are funds available in the Hillsborough Township Capital Improvement Fund in the amount of \$345,600.00; and

**WHEREAS**, contributions have been offered to the Township of Hillsborough from various groups that support the Library. These groups wish to contribute funds to the Township for the purchase of furniture for the new Library totaling \$150,000.00; and
