

ORDINANCE 2004-32

AN ORDINANCE APPROPRIATING CERTAIN MONIES HELD BY AND GRANTS TO BE RECEIVED BY THE TOWNSHIP OF HILLSBOROUGH, COUNTY OF SOMERSET, STATE OF NEW JERSEY, FOR THE PURCHASE OF VARIOUS CAPITAL IMPROVEMENTS IN THE AMOUNT OF \$258,500.00 IN AND FOR THE TOWNSHIP OF HILLSBOROUGH.

WHEREAS, there are funds available in the Hillsborough Township Capital Improvement Fund in the amount of \$76,500.00; and

WHEREAS, there are funds available in the Hillsborough Township Capital Fund Balance in the amount of \$80,000.00; and

WHEREAS, grants have been awarded to the Township of Hillsborough from the County of Somerset entitled Historic Preservation Grant in the amount of \$15,000; and
