

**ORDINANCE 2004-42**

**AN ORDINANCE AMENDING CHAPTER 143 (VEHICLES AND TRAFFIC) ARTICLE XII (SCHEDULES) SECTION 30 (SCHEDULE I: NO PARKING) OF THE MUNICIPAL CODE OF THE TOWNSHIP OF HILLSBOROUGH, COUNTY OF SOMERSET, STATE OF NEW JERSEY**

**BE IT ORDAINED** by the Township Committee of the Township of Hillsborough, County of Somerset, State of New Jersey as follows:

**Section 1:** Chapter 143, Article XII, Section 30 of the Municipal Code of the Township of Hillsborough shall be amended by adding additional no parking zones as follows:

Name of Street	Side	Location
<u>Farm Road</u>	<u>South</u>	<u>100 feet West of Andria Avenue to 50 feet East of Andrea Avenue.</u>
<u>Farm Road</u>	<u>North</u>	<u>50 feet East and West of 79, 73 Farm Road</u>
<u>Farm Road</u>	<u>South</u>	<u>50 feet East of Wildflower Lane to 50 feet West of 70, 74, 76 Farm Road</u>
<u>Farm Road</u>	<u>North</u>	<u>50 feet East and West of Robin Road (Western Intersection)</u>
<u>Farm Road</u>	<u>North</u>	<u>75 feet East and West of 49, 57 Farm Road</u>
<u>Farm Road</u>	<u>South</u>	<u>50 feet East of 46 Farm Road to 50 feet West of Cardinal Lane</u>
<u>Farm Road</u>	<u>North</u>	<u>50 feet East and West of 29, 43 Farm Road</u>
<u>Farm Road</u>	<u>South</u>	<u>50 feet East and West of 26, 28, 30, 32 Farm Road</u>
<u>Farm Road</u>	<u>South</u>	<u>50 feet East and West of Brookside Lane</u>
<u>Farm Road</u>	<u>North</u>	<u>50 feet East and West of John Hancock Avenue</u>

**Section 2:** Chapter 143, Article XII, Section 30 of the Municipal Code of the Township of Hillsborough shall be amended as follows:

Name of Street	Side	Location
<u>Andria Avenue</u>	<u>East</u>	<u>50 feet north and south of Brookside Lane</u>

**Section 3:** This ordinance shall take effect upon its adoption, passage and publication according to law.
