

ORDINANCE #6-14

ORDINANCE PROVIDING FOR VARIOUS IMPROVEMENTS OR PURPOSES TO BE UNDERTAKEN IN AND BY THE TOWNSHIP OF JEFFERSON, IN THE COUNTY OF MORRIS, NEW JERSEY, AND APPROPRIATING \$451,620 THEREFOR FROM THE CAPITAL IMPROVEMENT FUND OF THE TOWNSHIP.

BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF JEFFERSON, IN THE COUNTY OF MORRIS, NEW JERSEY, AS FOLLOWS:

The improvements described in Section 2 of this ordinance are hereby authorized as general improvements to be made or acquired by The Township of Jefferson, in the County of Morris, New Jersey. For the said improvements or purposes stated in said Section 2, there is hereby appropriated the sum of \$451,620 from moneys available in the Capital Improvement Fund of the Township.

The improvements hereby authorized and the several purposes for which said appropriation is made are as follows: the acquisition of new and additional equipment including Laser Fiche equipment for use by the Clerk's Office, a photocopier for use by the Administration Department of the Township, a radio tower, computer and communication equipment for use by the various departments of the Township, vehicles for Dial-a-Ride, radar units, fire extinguishers, police car conversion equipment, computer equipment and fingerprinting equipment for use by the Police Department of the Township, computer equipment and shop equipment for use by the Department of Public Works of the Township, and electronic sign boards and a utility vehicle for the Recreation Department of the Township; the upgrade of the Historical Society building; the installation of a traffic light on Berkshire Valley Road; and the preservation and storage of minute books and permanent

documents, including, for all of the foregoing, all necessary and appurtenant equipment, accessories, attachments, work and materials, and all as shown on and in accordance with the plans and specifications therefor on file or to be filed in the office of the Township Clerk and hereby approved.

The capital budget or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith and the resolutions promulgated by the Local Finance Board showing all detail of the amended capital budget or temporary capital budget and capital program as approved by the Director, Division of Local Government Services are on file with the Township Clerk and are available for public inspection.

This ordinance shall take effect after publication after final adoption, as provided by law.
