

ORDINANCE No. 1-15

ORDINANCE CREATING CHAPTER 194 OF THE JEFFERSON TOWNSHIP MUNICIPAL CODE ENTITLED "DIRECT DEPOSIT" AND REQUIRING THAT THE NET PAY OF ALL FULL-TIME AND REGULAR PART-TIME MUNICIPAL EMPLOYEES BE MADE BY DIRECT DEPOSIT

WHEREAS, N.J.S.A. 52:14-15f(b) provides that upon the adoption of an Ordinance, a municipality may make it mandatory that compensation of all full-time and regular part-time municipal employees be done by direct deposit into a financial institution; and

WHEREAS, the Township is desirous of adopting such an Ordinance, which shall result in cost savings to the Township and create a safer payment procedure for employees.

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Jefferson, County of Morris, State of New Jersey, that there is hereby created Chapter 194 of the Jefferson Township Municipal Code, entitled "Direct Deposit" as follows:

SECTION I

- §194.1 The net pay of all full-time employees of the Township, including regular part-time Township employees shall be made by direct deposit only to a financial institution designated by the employee.
- §194.2 The Chief Financial Officer of the Township shall be responsible for implementing the provisions of this Ordinance, and for the payment of all employees' compensation through direct deposit.

SECTION II

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistencies.

SECTION III

If any article, section, subsection, paragraph, phrase or sentence is, for any reason, held to be unconstitutional or invalid, said article, section, subsection, paragraph, phrase or sentence shall be deemed severable.

SECTION IV

This Ordinance shall take effect immediately upon final publication as provided by law.
