#### ORDINANCE NO. 12 - 09

ORDINANCE AMENDING CHAPTER 7 OF THE
JEFFERSON TOWNSHIP MUNICIPAL CODE ENTITLED
"ADMINISTRATION OF GOVERNMENT" AND MORE
PARTICULARLY ARTICLE X ENTITLED "DEPARTMENT
OF RECREATION, SENIOR AND VETERAN SERVICES"
SUBSECTION (B) ENTITLED "RECREATIONAL FEES" BY
ESTABLISHING AND/OR INCREASING FEES

**BE IT ORDAINED** by the Township Council of the Township of Jefferson, County of Morris, State of New Jersey, that Chapter 7 of the Jefferson Township Municipal Code, entitled "Administration of Government" is hereby amended by amending Article X entitled "Department of Recreation, Senior and Veteran Services," more particularly Section 7-53(B) entitled "Recreational Fees" by deleting said section in its entirety and replacing it with the following:

## **SECTION I**

## § 7-53(b). Recreational Fees.

There is hereby established the following recreational fees:

#### **Bus Trips**

To be determined by vendor and bussing costs, plus administrative fee up to \$5 per person

#### **Challenger Sports**

Up to \$45 per season (for the Special Needs)

#### **Challenger Horsemanship Program**

\$150 to \$200 (for the Special Needs)

# **Horsemanship Program**

\$180 to \$230

#### Karate

Up to \$55 for 10 classes Family discounts **to be determined** by the Karate School

## Rentals - Field/Playground

Local Township Sponsored Non-Profit Sports Programs - No Fees Local Non-Township Sponsored Non-Profit Sports Programs - \$60 per 2-hour game/practice

Corporate, Private, or Out of town groups - \$75 per 2-hour game/practice Local Non-Profit Non-Sports Related programs (i.e. churches, scouts) - \$35 per 2-hour event or community service in lieu of payment at the rate of 1 hour of service per 1 hour of rental

# **Rentals - Camp Jefferson**

Community Lodge - \$200 for 4-hour rental

Recreation Hall - \$125 for 4-hour rental

Single Cabin - \$25 for 2-hour rental

Entire Camp premises - \$700 for entire day

Community Service can be provided in lieu of payment for local non-profit groups at a rate of 1 hour of service per 1 hour of rental

# **Rutgers S.A.F.E.T.Y. Clinic**

Individuals who are coaching for a Jefferson Township sponsored program – No Fee

Individuals who do not coach a Jefferson Township sponsored program - \$25.50

#### Senior Center

Up to \$1 dues per year Up to \$15 per craft class

#### **Skate Park**

\$35 for annual membership – resident \$50 for annual membership – non-resident \$5 for daily fee

#### Ski Club

Mountain pass price **to be determined** by ski resort \$5 administrative fee added to cost of mountain pass Bus price from \$85 to \$100 for full program

## **Special Events**

Refreshments \$.50 to \$3 (Drinks/individually-wrapped snacks/hot dogs, etc.) Hay rides up to \$3 per person

# **Sports Squirts**

\$115 to \$125 (for ages 3 to 5 years old)

Sports Camps \$99 to \$200

## Summer Day Camp (Fees per child)

\$145 to \$165 per 3 day week

\$185 to \$205 per 5 day week

\$30 discount per week for Early Bird Registration

(early bird deadline to be set by the Recreation Department)

\$10 discount per week for campers who are residents

\$10 discount per sibling per week registered for same 5-day weeks

Pro-rated daily discount during holiday week (July 4th)

\$5 to \$25 for general electives

\$20 to \$30 for sports clinics

\$130 to \$175 for Horse Grooming elective

\$4 to \$6 per day for transportation to camp only

Trip costs to be determined by vendor & bussing expenses plus administrative fee up to \$3

Chow Down Thursdays \$3 to \$6 per meal

Fun Food Fridays \$2 to \$6 per meal

Refreshments \$.50 to \$2 (drinks/individually wrapped snacks)

Souvenir prices to be set by vendor plus administrative fee up to \$3

Before Care – Up to \$30 per week

After Care – Up to \$40 per week

Before and After Care – Up to \$55 per week

Parents' Night Out - \$15 for one child, \$25 for two children, \$35 for three or more children for four hour program. Additional \$5 per family to keep child in after care before the parents' night out program begins.

#### Track and Field

\$55 to \$75 per season

## Yoga/Pilates

Up to \$85 for 8 classes

## **SECTION II**

All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistencies.

# **SECTION III**

If any article, section, subsection, paragraphs, phrase or sentence is, for any reason, held to be unconstitutional or invalid, said article, section, subsection, paragraph, phrase or sentence shall be deemed severable.

# **SECTION IV**

This Ordinance shall take effect immediately upon final publication as provided by law.
