**ORDINANCE #17-09**

**ORDINANCE PROVIDING FOR VARIOUS IMPROVEMENTS OR PURPOSES TO BE UNDERTAKEN IN AND BY THE TOWNSHIP OF JEFFERSON, IN THE COUNTY OF MORRIS, NEW JERSEY, AND APPROPRIATING \$175,790 THEREFOR FROM THE CAPITAL IMPROVEMENT FUND OF THE TOWNSHIP.**

**BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF JEFFERSON, IN THE COUNTY OF MORRIS, NEW JERSEY, AS FOLLOWS:**

Section 1. The improvements described in Section 2 of this ordinance are hereby authorized as general improvements to be made or acquired by The Township of Jefferson, in the County of Morris, New Jersey. For the said improvements or purposes stated in said Section 2, there is hereby appropriated the sum of \$175,790 from moneys available in the Capital Improvement Fund of the Township.

Section 2. The improvements hereby authorized and the several purposes for which said appropriation is made are as follows: the acquisition of new and additional equipment including a vehicle for the Animal Control Official, plows and spreaders for the Department of Public Works, a photocopier for the Administration Department, a two station folder inserter for the Collections Department, computer equipment for the Police Department and various Township Departments, bronze seal and lettering for Council Chambers; the renovation of the Museum by the replacement of the back door and the kitchen floor, and the installation of soffits and Council Chambers by the upgrade of the electrical and speaker system thereof; and the preservation and storage of minute books and tax books, including, for all of the foregoing, all necessary and appurtenant equipment, accessories, attachments, work and materials, and all studies, surveys, engineering, legal, advertising and other costs associated

therewith, and all as shown on and in accordance with the plans and specifications therefor on file or to be filed in the office of the Township Clerk and hereby approved.

Section 3. The capital budget or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith and the resolutions promulgated by the Local Finance Board showing all detail of the amended capital budget or temporary capital budget and capital program as approved by the Director, Division of Local Government Services are on file with the Township Clerk and are available for public inspection.

Section 4. This ordinance shall take effect after publication after final adoption, as provided by law.
