#### **ORDINANCE NO. 22-09**

# ORDINANCE AUTHORIZING THE EXECUTION OF AN INTER-LOCAL SERVICES AGREEMENT WITH THE TOWNSHIP OF MT. ARLINGTON, MORRIS COUNTY, TO SHARE CONSTRUCTION CODE SERVICES

**WHEREAS**, the Township of Jefferson and the Township of Mt. Arlington share a contiguous border and have both the proximity and size that makes sharing of a Construction Official and building code inspection services feasible; and

**WHEREAS,** municipalities are permitted to share services pursuant to the Uniform Shared Services and Consolidation Act (<u>N.J.S.A.</u> 40A:65-1 *et seq.*), as well as provisions of the Uniform Construction Code, N.J.A.C. 5:23-4.6; and

**WHEREAS,** there is a mutually beneficial opportunity to further improve the efficacy of a Construction Official and building code inspection services for each municipality, and in reducing the cost of delivering these services for the respective local governments; and

WHEREAS, each municipality is desirous of entering into this Agreement; and

**WHEREAS,** the parties have approved an Agreement, which is on file in the Office of the Municipal Clerk for each municipality; and

**WHEREAS,** N.J.A.C. 5:23-4.6 requires the entry into such agreements be approved by Ordinance.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Council of the Township of Jefferson, County of Morris, State of New Jersey, as follows:

### **SECTION 1.**

The Mayor and Clerk are hereby authorized to execute the Shared Services Agreement with the Township of Mt. Arlington in the form on file in the Office of the Municipal Clerk.

#### **SECTION II**

All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistencies.

## **SECTION III**

If any article, section, subsection, paragraphs, phrase or sentence is, for any reason, held to be unconstitutional or invalid, said article, section, subsection, paragraph, phrase or sentence shall be deemed severable.

#### **SECTION IV**

This Ordinance shall take effect immediately upon final publication as provided by law.
