

**ORDINANCE NO. 15-10**

**ORDINANCE AMENDING CHAPTER 235 OF THE JEFFERSON  
TOWNSHIP MUNICIPAL CODE ENTITLED “FEES, GENERAL” AND  
MORE PARTICULARLY BY AMENDING SUBSECTION 235-16  
ENTITLED “HEALTH DEPARTMENT FEES”**

**BE IT ORDAINED** by the Township Council of the Township of Jefferson, County of Morris, State of New Jersey, that Chapter 235 of the Jefferson Township Municipal Code, entitled “Fees, general” is hereby amended by amending subsection 235-16 entitled “Health Department fees” as follows:

**SECTION I**

Subsection “A” regarding burial permit fee shall be amended to provide that a burial permit fee is \$5 and not \$15.

Subsection “B” regarding disinterment permit for removal or relocation of remains shall remain at \$15.

**SECTION II**

All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistencies.

**SECTION III**

If any article, section, subsection, paragraphs, phrase or sentence is, for any reason, held to be unconstitutional or invalid, said article, section, subsection, paragraph, phrase or sentence shall be deemed severable.

**SECTION IV**

This Ordinance shall take effect immediately upon final publication as provided by law.
