**“RESOLUTION AUTHORIZING CONTRACTS WITH CERTAIN APPROVED

WHEREAS, the Township of Jefferson may, by resolution and without advertising for bids in accordance with N.J.S.A. 40A:11-11 et seq. of the Local Public Contracts Law, purchase and goods or services under the approved **Cranford Police Cooperative Pricing System contracts entered into on behalf of the Township of Cranford**; and

WHEREAS, the Township of Jefferson has the need on a timely basis to purchase goods or services utilizing **State Contracts**; and

WHEREAS, the Cranford Police Cooperative Pricing System contract **#47-CPCPS, Contract 16-01-#2**, was awarded to **Beyer Ford, 170 Ridgedale Avenue, Morristown, New Jersey 07960**; and


WHEREAS, the Township of Jefferson desires to purchase, **one(1) 2017 Ford SUV Police Interceptor AWD vehicle with options and extended warranty in an amount not to exceed \$28,488.75** through this resolution and properly executed contract, which shall be subject to all the conditions applicable to the current Cranford Police Cooperative Pricing System contract; and

WHEREAS, pursuant to N.J.A.C. 5:30-5.5 (b) a certificate showing availability of funds has been provided to the Township by the Chief Financial Officer of the Township, certifying that the funds for said contract are available.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Jefferson that the Township Administrator is authorized to purchase **(1) 2017 Ford SUV Police Interceptor AWD vehicle with options and extended warranty from the approved Cranford Police Cooperative Pricing System #47-CPCPS, contract 16-01-#2 in an amount not to exceed \$28488.75 from Beyer Ford, 170 Ridgedale Avenue, Morristown, New Jersey 07960.**


