**“RESOLUTION AUTHORIZING THE WAIVER OF IMPOSITION OF INTEREST CHARGES  
AND REFUND OF INTEREST PAID FOR MUNICIPAL TAXES DUE FEBRUARY 1, 2017 – BLOCK 290, LOT 1”**

**WHEREAS**, the **first quarter 2017** municipal real estate taxes were due **February 1, 2017**; and

**WHEREAS**, a grace period of ten (10) days is allowed before the imposition of interest charges to property owners; and

**WHEREAS**, **Pamela Graham, owner of Block 290, Lot 1, 24 East Shawnee Trail** was unable to make payment on **first quarter 2017** municipal real estate taxes until **February 13, 2017** due to a personal tragedy which was the loss of her home due a fire; and


**WHEREAS**, due to the payment of **first quarter 2017** municipal real estate taxes after the grace period, interest charges were imposed on the property owner in the amount of **\$13.61**; and

**WHEREAS**, the Administrator recommended the waiver of imposition of interest charges and refund of interest paid for **first quarter 2017** municipal real estate taxes; and

**WHEREAS**, the Township Council wishes to refund interest paid by the property owner for **first quarter 2017** municipal real estate taxes in the amount of **\$13.61**.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of Jefferson, County of Morris, State of New Jersey, that the Chief Financial Officer is hereby authorized and directed to issue a refund in the amount of **\$13.61** for interest paid on **first quarter 2017** municipal real estate taxes to **Pamela Graham, owner of Block 290, Lot 1, 24 East Shawnee Trail**.
