WHEREAS, the Township of Jefferson may, by resolution and without advertising for bids, in accordance with N.J.S.A. 40A:11-11 et seq. of the Local Public Contracts Law, purchase goods or services under the **State of New Jersey Cooperative Purchasing Program for any State Contracts entered into on behalf of the State Division of Purchase and Property in the Department of the Treasury**; and

WHEREAS, the Township of Jefferson has the need on a timely basis to purchase goods or services utilizing **State contracts**; and


WHEREAS, State Contracts T-0106 (A81329, A81360) and T-0790 (A80947, A80948, A80953), were awarded to Turn Out Fire & Safety, Inc., 3468 Kennedy Boulevard, Jersey City, New Jersey, 07307 for Firefighter Clothing, Police Clothing, Fire Equipment & Homeland Security Equipment; and

WHEREAS, the Township of Jefferson desires to purchase Firefighter Clothing, Police Clothing, Fire Equipment & Homeland Security Equipment in an amount not to exceed \$30,000.00 through this resolution and properly executed contract, which shall be subject to all the conditions applicable to the current **State of New Jersey Cooperative Purchasing Program contracts**; and




