ORDINANCE #17-04

“ORDINANCE PROVIDING FOR VARIOUS IMPROVEMENTS OR PURPOSES TO BE UNDERTAKEN IN AND BY THE TOWNSHIP OF JEFFERSON, IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY, AND APPROPRIATING \$540,860 THEREFOR FROM VARIOUS FUNDS OF THE TOWNSHIP”

BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF JEFFERSON, IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY, AS FOLLOWS:

SECTION 1.

The improvements described in Section 2 of this Ordinance are hereby authorized as general improvements to be made or acquired by the Township of Jefferson, in the County of Morris, State of New Jersey. For the said improvements or purposes stated in said Section 2, there is hereby appropriated the sum of **\$540,860** from moneys available in the Capital Improvement Fund and the Reserve for Debt Service of the Township.

SECTION 2.

The improvements hereby authorized and the several purposes for which said appropriation is made are as follows: the acquisition of new and additional computer equipment for use by various departments of the Township; the acquisition of new and additional equipment including, video cameras for use at the municipal complex, one (1) utility vehicle and light bars for use by the Police Department of the Township, equipment for use by the Fire Departments of the Township, shop equipment for use by the Department of Public Works of the Township, and one (1) vehicle for use by the Dial-A-Ride office of the Township; the paving of Milton Road in and by the Township; the improvement of the municipal complex by the upgrade of the bathrooms thereat; and the improvement of the Township Museum by the upgrade of the heating, ventilation and air conditioning system, together with, for all of the foregoing, all necessary and appurtenant equipment, accessories, attachments, work and materials, and all as shown on and in accordance with the plans and specifications therefor on file or to be filed in the office of the Township Clerk and hereby approved.

SECTION 3.

The capital budget or temporary capital budget of the Township is hereby amended to conform with the provisions of this Ordinance to the extent of any inconsistency herewith and the resolutions promulgated by the Local Finance Board showing all detail of the amended capital budget or temporary capital budget and capital program as approved by the Director, Division of Local Government Services are on file with the Township Clerk and are available for public inspection.

SECTION 4.

This Ordinance shall take effect after publication after final adoption, as provided by law.




