ORDINANCE #17-07

**“ORDINANCE PROVIDING FOR THE ACQUISITION OF NEW EQUIPMENT
BY THE TOWNSHIP OF JEFFERSON, IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY, AND
APPROPRIATING \$44,000 THEREFOR FROM THE RECREATION/OPEN SPACE TRUST FUND
AND THE CAMP RESERVE FUND OF THE TOWNSHIP”**

BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF JEFFERSON, IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY, AS FOLLOWS:

SECTION 1

The improvements described in Section 2 of this Ordinance are hereby authorized as general improvements to be made or acquired by The Township of Jefferson, in the County of Morris, State of New Jersey. For the said improvement or purpose stated in said Section 2, there is hereby appropriated the sum of **\$44,000**, to the extent of **\$19,000**, from moneys available in the Recreation/Open Space Trust Fund of the Township and, to the extent of **\$25,000**, from moneys available in the Camp Reserve Fund of the Township.

SECTION 2

The improvement or purpose for the financing of which the appropriation is made as provided in Section 1 of this Ordinance is the acquisition by purchase of one (1) gator vehicle, one (1) utility trailer and scoreboards, together with all necessary and appurtenant equipment, accessories, attachments, necessary therefor or incidental thereto, all as shown on and in accordance with the plans and specifications therefor on file or to be filed in the office of the Township Clerk and hereby approved.

SECTION 3

The capital budget or temporary capital budget of the Township is hereby amended to conform with the provisions of this Ordinance to the extent of any inconsistency herewith and the resolutions promulgated by the Local Finance Board showing all detail of the amended capital budget or temporary capital budget and capital program as approved by the Director, Division of Local Government Services are on file with the Township Clerk and are available for public inspection.

SECTION 4

This Ordinance shall take effect after publication after final adoption, as provided by law.


