ORDINANCE #17-10

"ORDINANCE PROVIDING FOR VARIOUS IMPROVEMENTS TO BE UNDERTAKEN BY THE TOWNSHIP OF JEFFERSON, IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY, AND APPROPRIATING \$497,678 THEREFOR FROM THE PROCEEDS OF A GRANT FROM THE FEDERAL EMERGENCY MANAGEMENT AGENCY AND MONEYS IN THE CAPITAL IMPROVEMENT FUND AND RESERVE FOR DEBT SERVICE OF THE TOWNSHIP"

BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF JEFFERSON, IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY, AS FOLLOWS:

SECTION 1

The improvements described in Section 2 of this Ordinance are hereby authorized as general improvements to be made or acquired by the Township of Jefferson, in the County of Morris, State of New Jersey. For the said improvements or purposes stated in said Section 2, there is hereby appropriated the sum of \$497,678, to the extent of \$302,500 from the proceeds of a grant received or expected to be received by the Township from the Federal Emergency Management Agency as a grant-in-aid of financing said purposes and, to the extent of \$195,178 from moneys available in the Capital Improvement Fund and Reserve for Debt Service of the Township.

SECTION 2

The improvements hereby authorized and the purposes for which said appropriation is the upgrade of the Police and Emergency Services Communication Call Center; and the acquisition of new and additional equipment for use at Camp Jefferson, together with all necessary and appurtenant equipment, accessories, attachments, work and materials, necessary therefor or incidental thereto, all as shown on and in accordance with the plans and specifications therefor on file or to be filed in the office of the Township Clerk and hereby approved.

The capital budget or temporary capital budget of the Township is hereby amended to conform with the provisions of this Ordinance to the extent of any inconsistency herewith and the resolutions promulgated by the Local Finance Board showing all detail of the amended capital budget or temporary capital budget and capital program as approved by the Director, Division of Local Government Services are on file with the Township Clerk and are available for public inspection.

SECTION 4

This Ordinance shall take effect after publication after final adoption, as provided by law.
