ORDINANCE #17-14

**“ORDINANCE AMENDING CHAPTER 130 OF THE JEFFERSON TOWNSHIP MUNICIPAL CODE
ENTITLED “VEHICLES AND TRAFFIC” AND MORE PARTICULARLY SUBSECTION 130-13 ENTITLED
“STOPPING AND STANDING PROHIBITED”**

BE IT ORDAINED by the Township Council of the Township of Jefferson, County of Morris, State of New Jersey, that the Jefferson Township Municipal Code, entitled “Vehicles and Traffic” and more particularly Subsection 130-13 entitled “Stopping and Standing Prohibited” is hereby amended as follows:

SECTION I

§130-13 entitled “Stopping and Standing Prohibited” is amended by adding the following:

Name of Street	Side	Location
Jefferson Drive	Both	From the intersection of Jefferson Drive and Espanong Road to the intersection of Jefferson Drive and Winding Ridge Road

SECTION II

All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistencies.

SECTION III


If any article, section, subsection, paragraph, phrase or sentence is, for any reason, held to be unconstitutional or invalid, said article, section, subsection, paragraph, phrase or sentence shall be deemed severable.

SECTION IV


This Ordinance shall take effect immediately upon final publication as provided by law.




