**"RESOLUTION AUTHORIZING CHANGE ORDER NO. 1 AND APPROVING FINAL PAYMENT –
PL CUSTOM EMERGENCY VEHICLES FOR MILTON FIRST AID SQUAD
AND JEFFERSON TOWNSHIP RESCUE SQUAD AMBULANCES"**

WHEREAS, a contract was awarded to PL Custom Emergency Vehicles for two (2) ambulances for the Milton First Aid Squad (MFAS) and the Jefferson Township Rescue Squad (JTRS) in the amount of \$172,303.50 and \$174,694.50, respectively, and totaling \$346,998.00; and

WHEREAS, MFAS has submitted and recommended minor modifications in the amount of \$1,060.00; and

WHEREAS, JTRS has submitted and recommended minor modifications in the amount of \$1,105.00; and

WHEREAS, the total changes for Change Order No. 1 in the amount of \$2,165 reflect a 0.6% increase in the original contract amount and increase the contract total to \$349,163.00; and

WHEREAS, a previous payment was made in the amount of \$71,802.00 for completion of the ambulance chasses; and

WHEREAS, the Chief Financial Officer has certified that funds are available for said payment; and


WHEREAS, in accordance with N.J.A.C. 5:30-11.3, the change order has not caused the original contract price to be exceeded by more than twenty percent (20%); and

WHEREAS, in accordance with N.J.A.C. 5:30-11.8, this change order constitutes minor modifications to effect economies, improve service or resolve minor problems.


NOW, THEREFORE, BE IT RESOLVED, that the Township Council of the Township of Jefferson, County of Morris, State of New Jersey, hereby approves Change Order No.1 in the amount \$2,165.00 and Final payment in the amount of \$277,361.00.

BE IT FURTHER RESOLVED, that payment(s) will be made pending satisfactory delivery of the respective MFAS and JTRS ambulances.




