CONTRACTING UNITS – JESCO”**

WHEREAS, the Township of Jefferson may, by resolution and without advertising for bids in accordance with N.J.S.A. 40A:11-11 of the Local Public Contracts Law, purchase and goods or services under the **New Jersey State Approved Co-op #65MCESCCPS, The Educational Services Commission of New Jersey Co-op contracts entered into on behalf of said Commission**; and

WHEREAS, the Township of Jefferson has the need on a timely basis to purchase goods or services utilizing Cooperative contracts; and

WHEREAS, ESCNJ contract 15/16-08 was awarded to JESCO, 118 St. Nicholas Ave., South Plainfield, New Jersey, 07080; and

WHEREAS, the Township of Jefferson intends to purchase in an **a New 2017 Bomag BW90 AD-5 Tandem Asphalt Roller** in an **amount not to exceed \$31,010.55** through this resolution and properly executed contract, which shall be subject to all the conditions applicable to current Educational Services Commission of New Jersey contracts; and

WHEREAS, pursuant to N.J.A.C. 5:30-5.5 (b) a certificate showing availability of funds has been provided to the Township by the Chief Financial Officer of the Township, certifying that the funds for said contract are available.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Jefferson that the Township Administrator is authorized to purchase **a New 2017 Bomag BW90 AD-5 Tandem Asphalt Roller** in an **amount not to exceed \$31,010.55 from Jesco, 118 St. Nicholas Ave., South Plainfield, New Jersey, 07080**.


