**WHEREAS**, the Township of Jefferson may, by resolution and without advertising for bids in accordance with N.J.S.A. 40A:11-11 of the Local Public Contracts Law, purchase and goods or services under the **New Jersey State Approved Co-op #65MCESCCPS, The Educational Services Commission of New Jersey Co-op contracts entered into on behalf of said Commission;** and

**WHEREAS**, the Township of Jefferson has the need on a timely basis to purchase goods or services utilizing Cooperative contracts; and


**WHEREAS, ESCNJ contracts 15/16-08 & 15/16-53 were awarded to Cherry Valley Tractor Sales, 35 Route 70, Marlton, New Jersey, 08053-3099 for Kubota 4WD Utility Vehicles;** and

**WHEREAS**, the Township of Jefferson intends to purchase **(2) New Kubota 4WD Utility Vehicles in an amount not to exceed \$25,626.74** through this resolution and properly executed contract, which shall be subject to all the conditions applicable to current the Educational Services Commission of New Jersey (ESCNJ) contracts; and

**WHEREAS**, pursuant to N.J.A.C. 5:30-5.5 (b) a certificate showing availability of funds has been provided to the Township by the Chief Financial Officer of the Township, certifying that the funds for said contract are available; and

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of Jefferson that the Township Administrator is authorized to **(2) New Kubota 4WD Utility Vehicles in an amount not to exceed \$25,626.74 from Cherry Valley Tractor Sales, 35 Route 70, Marlton, New Jersey, 08053-3099.**
