**“RESOLUTION AUTHORIZING CONTRACTS WITH CERTAIN APPROVED
NJ STATE COOPERATIVE PRICING COUNCIL CONTRACT VENDOR FOR CONTRACTING UNITS
– ATLANTIC COMMUNICATIONS”**

WHEREAS, the Township of Jefferson, may by resolution and without advertising for bids, in accordance with N.J.S.A. 40A:11 et seq of the Local Public Contracts Law, purchase goods or services under the **State of New Jersey Cooperative Purchasing Program for any state contracts entered into on behalf of the State of the Division of Purchase and Property in the Department of the Treasury; and**

WHEREAS, the Township of Jefferson has the need on a timely basis to purchase goods or services utilizing State contracts; and

WHEREAS, State Contracts #T-0106 (A81334), T-0109 (A83917, A83927) were awarded to **Atlantic Communications, 664 Route 15 South, Lake Hopatcong, New Jersey 07849** for radio communications equipment, repairs and installation and vehicle emergency sounds & lighting; and


WHEREAS, the Township of Jefferson desires to purchase, a new Police Department Dispatch Center which supports all police, fire and first aid agencies in an amount not to exceed \$222,000.00 through this resolution and properly executed contract, which shall be subject to all the conditions applicable to the current New Jersey State Cooperative Purchasing Program; and

WHEREAS, pursuant to N.J.A.C. 5:30-5.3 through 5:30-5.5 (b) a certificate showing availability of funds has been provided to the Township by the Chief Financial Officer of the Township, certifying that the funds for said contract are available.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Jefferson, County of Morris, State of New Jersey, that the Township Administrator is authorized to purchase a new Police Department Dispatch Center which supports all police, fire and first aid agencies in an amount not to exceed \$222,000.00 from Atlantic Communications, 664 Route 15 South, Lake Hopatcong, New Jersey 07849.


