**“RESOLUTION AMENDING PREVIOUS RESOLUTION AUTHORIZING RENEWAL OF
PLENARY RETAIL CONSUMPTION LICENSE #1414-33-016-018
HERETOFORE ISSUED TO NEW CLUB 15 INC. WITH SPECIAL CONDITIONS”**

WHEREAS, the Township Council, Township of Jefferson, County of Morris, State of New Jersey had received an application for renewal of the above referred to Liquor License; and

WHEREAS, the license holder had completed the necessary State of New Jersey, Division of Alcoholic Beverage Control ABC Application, and paid the correct renewal fees to the Township Clerk for renewal of the Liquor License for the year 2017-2018; and

WHEREAS, a Resolution authorizing renewal of said license with special conditions, which previously did not apply to the license in question, was adopted by the Township Council on June 28, 2017; and

WHEREAS, the license holder objected to the special conditions imposed by said Resolution, and did in fact file a Notice and Petition of Appeal of said conditions with the State of New Jersey Division of Alcoholic Beverage Control, and did seek a stay of the conditions as imposed by the previous Resolution; and

WHEREAS, the Township agreed to an imposition of the stay of said conditions, without prejudice; and

WHEREAS, the Township filed an Answer to said Petition, and contested the allegations of said Petition, alleging that the Township had a right to impose the conditions; and

WHEREAS, the parties have entered into settlement negotiations; and

WHEREAS, the parties have agreed to amend the conditions previously set forth in the aforesaid Resolution, to which the license holder agrees.

NOW, THEREFORE, BE IT RESOLVED that the Township Council of the Township of Jefferson, County of Morris, State of New Jersey, hereby amends the previous approval for the renewal of the license for **New Club 15 Inc., License No. 1414-33-016-018**, for the period **July 1, 2017 through June 30, 2018**, and does hereby approve the application for renewal, which renewal is granted with conditions.


BE IT FURTHER RESOLVED that the following special conditions, pursuant to N.J.S.A. 33:1-32, are hereby imposed by the local governing body with the consent of the Licensee for the 2017-2018 licensing term.

1. Licensee shall provide three security personnel on the premises for Friday and Saturday night from 11:00 p.m. to 3:30 a.m. At least one of the security personnel on a rotating basis will be responsible for monitoring activities in the outside parking lot.
2. All security shall have shirts and/or indoor/outdoor jackets which clearly identify them as security personnel.
3. All security personnel shall provide their names, addresses and cell phone numbers to the local Police Department.
4. All security personnel will be fingerprinted as requested by the Jefferson Township Police Department.
5. Licensee will ensure that all outside lighting is in good working order.
6. Licensee shall provide a minimum of one security personnel on each night the Club is opened. Additional security as contained in Paragraph 1 shall be available on evenings where special events are held and/or holidays. Licensee shall notify the Municipal Clerk in writing at least 48 hours in advance of any special event; email is acceptable.
7. Licensee will not admit any new patrons after 2:00 a.m. on any night that the business is open and shall place a sign at the entrance of the premises advising the public that no new patrons will be admitted after 2:00 a.m.

8. All vehicles owned or operated by patrons shall be removed from the premises within 15 minutes of closing time. In the event a vehicle is not removed as a result of the patron's inability to remove the vehicle (mechanical problems and/or has elected to seek an alternate means of transportation), the vehicle will be appropriately marked by Licensee by placing a flyer on the windshield or by advising the Police Department that the vehicle will be remaining overnight.


