**“RESOLUTION AUTHORIZING THE CANCELLATION OF TAX AMOUNTS

WHEREAS, the Tax Collector certifies that there appears on the **2017 and 2018 tax records** amounts due; and

WHEREAS, the Township of Jefferson foreclosed on municipal liens on Final Judgment In Rem dated **May 25, 2017**; and

WHEREAS, the Township of Jefferson became the owner of record of: **Block 80, Lot 1; Block 489, Lot 6.02; Block 495, Lot 4; Block 525, Lot 11; Block 525, Lot 12; Block 477, Lot 12; Block 232, Lot 47**; and

WHEREAS, the 2017 Extended Property Tax Duplicate was updated prior to the 45 day waiting period after the Final Judgment of May 25, 2017 and as a result tax bills were issued for the following years and in the following amounts:


