WHEREAS, Fred Claus is also qualified to serve as a Deputy Emergency Management Coordinator for the Township of Jefferson; and

WHEREAS, Mickey DeLoreto is also qualified to serve as a Deputy Emergency Management Coordinator for the Township of Jefferson; and

WHEREAS, Andrew Schmidt is also qualified to serve as a Deputy Emergency Management Coordinator for the Township of Jefferson; and


WHEREAS, the Township Council is desirous of giving advice and consent to the Mayor's appointments of the Emergency Management Coordinator and Deputy Emergency Management Coordinators.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Jefferson, County of Morris, State of New Jersey, that William Craig is hereby appointed to the position of Emergency Management Coordinator for the Township of Jefferson for the three year term January 1, 2018 through December 31, 2020.

BE IT FURTHER RESOLVED that Paul Castimore, Fred Claus, Mickey DeLoreto and Andrew Schmidt are appointed to the position of Deputy Emergency Management Coordinator for the one year term January 1, 2018 through December 31, 2018.

BE IT FURTHER RESOLVED that a copy of this resolution be transmitted to the Morris County Office of Emergency Management.


