WHEREAS, **Roher Enterprises, Inc. d/b/a Roher Bus Sales** is the lowest responsible bidder and therefore, the contract should be awarded to said contractor; and

WHEREAS, pursuant to N.J.A.C. 5:30-5.5 (b) a certificate showing availability of funds has been provided to the Township by the Chief Financial Officer of the Township, certifying that the funds for said contract are available and are designated to a line item appropriations designated below and **totaling \$51,495.00**.



Please be advised that bids were received on 11/22/2017 for a Mobility Access Vehicle which is necessary for use in the Jefferson Township Dial A Ride program to transport handicap residents to and from doctor appointments, employment agencies medical facilities, etc. There were two successful bidders for this service. After careful review of the bids, viewing a 3 year old model of the same vehicle first hand and seeing that all paperwork is in order from both reputable bidders, I am recommending the bid be awarded to Roher Enterprises, Inc DBA Roher Bus Sales. Roher provided the lowest bid on the vehicle with a slightly higher cost in the warranty. Overall, there bid price was the highest of the two at \$51,495.00 vs. \$50,625.00, however, they offer the better warranty as well as a better delivery package.
