- NATIONAL FUEL OIL, INC.”**

WHEREAS, the Township of Jefferson may, by resolution and without advertising for bids in accordance with N.J.S.A. 40A:11-11 of the Local Public Contracts Law, purchase and goods or services under the **Somerset County Purchasing Division approved Co-op #2-SOCCP**, the Somerset County Purchasing Division contracts entered into on behalf of said Division; and

WHEREAS, the Township of Jefferson has the need on a timely basis to purchase goods or services utilizing Cooperative contracts; and

WHEREAS, SOCCP contract CC-0045-16 was awarded to National Fuel Oil, Inc., 175 Orange Street, Newark, New Jersey 07103; and

WHEREAS, the Township of Jefferson intends to purchase Regular Gasoline in an amount not to exceed \$225,000.00 through this resolution and properly executed contract, which shall be subject to all the conditions applicable to current **Somerset County Purchasing Division contracts**; and


WHEREAS, pursuant to N.J.A.C. 5:30-5.5 (b) a certificate showing availability of funds has been provided to the Township by the Chief Financial Officer of the Township, certifying that funds for said contract are available and are designated to a line item appropriations designated below and **totaling \$225,000.00**.


