WHEREAS, the Township of Jefferson may, by resolution and without advertising for bids, in accordance with N.J.S.A. 40A:11-11 of the Local Public Contracts Law, purchase goods or services under the New Jersey State Approved Co-op #65MCESCCPS, Educational Services Commission of New Jersey (ESCNJ) Co-op contracts entered into on behalf of said Commission; and

WHEREAS, the Township of Jefferson has the need on a timely basis to purchase goods or services utilizing State contracts; and

WHEREAS, the ESCNJ contract **ESCNJ 17/18-45** was awarded to Cablevision Lightpath NJ LLC.-Altice USA, 200 Jericho Quadrangle, Jericho, New York, 11753 for ACT Hosted Phone Services and support; and

WHEREAS, the Township of Jefferson desires to purchase Digital Readiness For Learning And Assessment Project – Internet Access and Telecommunications in an amount not to exceed \$50,000.00 through this resolution and properly executed contract, which shall be subject to all the conditions applicable to the current ESCNJ contract; and


