WHEREAS, a contract was awarded to Power With Prestige, Inc. for Milton First Aid Squad Generator, Contract No. BLD-60-1A; and

WHEREAS, the Township Engineer has submitted and recommended **Change Order No. 1** dated 3/12/18 in the amount of **-\$7,100.00** to reflect items adjusted to agree with as-built quantities, decreasing the contract total to **\$39,300.00 (an overall adjustment of -15.30% to the original contract amount)**; and

WHEREAS, the Township Engineer has submitted **Current Estimate No. 2** in the amount of **\$13,050.00** for work completed and accepted; and


WHEREAS, the Chief Financial Officer has certified that funds are available for said payment.


