**ORDINANCE #18-03**

**ORDINANCE AMENDING CHAPTER 353 OF THE JEFFERSON TOWNSHIP MUNICIPAL CODE ENTITLED "PARKS"  
AND MORE PARTICULARLY SECTION 353-2, ENTITLED "PUBLIC PARK PROPERTIES CURFEW"**

**BE IT ORDAINED** by the Township Council of the Township of Jefferson, County of Morris, State of New Jersey, that Chapter 353 of the Jefferson Township Municipal Code, entitled "PARKS" is hereby amended by amending sub-section 353-2 entitled "Public park properties curfew", by deleting said sub-section in its entirety, and in its place and stead shall be the following:

**SECTION I**

**Section 353-2. Public park properties curfew.**

It shall be unlawful for any person to be present in any public parks owned and operated by the Township of Jefferson, including all Township recreation facilities, ball fields and playgrounds, as listed by the Township Department of Recreation, between sunset and sunrise, prevailing time, unless such presence is by a person attending a function at any of said public parks, either organized or approved by the Township Department of Recreation.

**SECTION II**

All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistencies.

**SECTION III**

If any article, section, subsection, paragraphs, phrase or sentence is, for any reason, held to be unconstitutional or invalid, said article, section, subsection, paragraph, phrase or sentence shall be deemed severable.

**SECTION IV**


This Ordinance shall take effect immediately upon final publication as provided by law.


